Contenu

As a first step, an introduction will clarify the key concepts in order to understand the difference between migration studies and mobility research. We will question some of the assumptions underlying the standard definitions of international migration, located within the framework of the international state system. The linkage also raises the issue of the agency of those who are or have been literally on the move. In this recent past, logics of free movement, security and human rights discourses and anti-immigrant populist mobilization have been at work simultaneously, questioning and re-arranging established forms of inclusion and exclusion according to class, nationality, origin, religion and gender. We will therefore try to understand in a field-research how mobilities and migrations are perceived by ordinary citizens and migrants (French and/or German proficiency may be a requirement to take part to field work and present the findings in the last two final sessions.

Forme de l'évaluation

Students will have to analyze a source and read a reference text for each session. The group responsible for the session will have to deepen the problematic starting from a short bibliographic orientation. It will be in charge of a presentation of the references that will be followed by a reflection, discussion and synthesis.

Groups of students will have to participate in the second round to field work on perceptions of mobilities in sensitive agglomerations. There will be the possibility for a part of the class to participate in an accompanied group.

Students wishing to earn credits for this seminar will be required to deliver a 15-page paper at the end of the semester. This is based on the discussed literature and the field-work.

The final grade will be weighted as follows:

Presence, readings, participation, and presentation (30%) Field work and final sessions (30%) Essay (40%)

Note: Inability to submit written work in a timely manner, without good reason, will automatically result in a failure of the exercise (échec).
