Contenu

This seminar develops in the context of the CFA Institute research challenge and provides intense training in company analysis and presentation skills. Groups of 3 to 5 students carry out an in-depth analysis of a real-life company as if they were practicing equity analysts. Each group prepares an equity research report and a presentation to a panel of experts.

Each team can interact directly with the company in researching and preparing a company analysis at organized events. Each group is mentored by an industry professional who guides students during the preparation of the report and presentation. We also invite several guest speakers (heads of research, portfolio managers, and chief investment officers from Switzerland's leading financial firms) who bring their own insights on the financial analysts' profession.

Forme de l'évaluation

Final Report: 45%
Presentation: 45% computed as max (in-class presentation, final presentation)
Class Participation: 10%

To participate in the final presentation you need to have a 4 in the in-class presentation, else your grade is based only in the in-class presentation.

The winning team participates in the CFA Institute Research Challenge in Switzerland.
Reexamination session: Re-write and upgrade the research report.
