#### Contenu

This compulsory lecture course provides an introduction to English literature written in the sixteenth, seventeenth, and eighteenth centuries. Students will have the opportunity to read key works of literature from the Renaissance, Civil War and Interregnum, the Restoration, and the eighteenth century as we explore developments in prose, poetry and drama. Among the historical, political and intellectual developments addressed in the lectures are English Renaissance Humanism, the Reformation, the Civil Wars and other political disputes, Neoclassicism, and the Enlightenment. Students will be encouraged to explore different genres of drama, poetry and prose, including Interregnum drolls, Restoration comedies of manners, ballad operas, epic poetry, metaphysical poetry, mock-heroic poetry, satire and the development of prose fiction towards the novel.

The course will cover the years 1500-1790 and will be divided into four sub-categories: the Renaissance (c.1500-1642), the Civil Wars and Interregnum (c. 1642-1659), the Restoration (1660-1700), and the eighteenth century (to 1790). We will explore developments in poetry, drama and prose from 1500-1790 by considering examples of the key sub-genres associated with each literary period.

#### Forme de l'évaluation

A four-hour exam (évaluation externe, 100%). The exam is in two parts. In Part I (closed book) students will be asked a series of questions about the period 1500-1790. These questions will require short answers and will be based on information provided during the lectures, e.g 'Q. name two developments associated with the Restoration stage. A. The introduction of actresses and the use of movable scenery.'

In Part II of the exam (open book) students will be asked to write an argumentative essay on one of two topics. Part II will test students' reading and their knowledge and understanding of the key developments in drama, prose, or poetry over the period 1500-1790. Students are advised to plan their essay in advance by selecting (at least) two of the three genres to work on (prose, poetry, drama) and by choosing a set number of supporting texts from the exam reading list. In the exam they will be given two of the three genres to choose from and must write one essay e.g. in the exam you may be asked to write an argumentative essay on \*EITHER\* developments in prose fiction between 1500 and 1790, \*OR\* on developments in dramatic writing between 1500 and 1790; if you planned essays on drama and poetry then you will obviously choose to write an essay on drama. If you planned essays on prose and drama then you will be able to choose between the two topics.

Rattrapage: A four-hour exam in the next exam session (évaluation externe, 100%)

If we are forced to return to distance learning then the exam will consist of an online quiz (Part I) and a take-home exam essay (Part II) to be submitted within 24hrs.

#### Modalités de rattrapage

4hr exam, as above (closed book for Part I and open book for Part II), as the exam session following receipt of a failing grade. In the event of a sanitary crisis, the exam will be replaced by a Moodle quiz and a timed take-home essay.
