Contenu

This course provides a comprehensive introduction to the core concepts of corporate sustainability reporting, combining theoretical foundations, empirical evidence, and practical applications. Students will examine the motivations behind voluntary sustainability disclosure, analyze the conditions under which sustainability regulation is effective, and evaluate the impacts of such disclosures on firms and stakeholders.

Topics covered include:

- Fundamental concepts of corporate sustainability and reporting, e.g., the concept of materiality in sustainability reporting
- Motivations and effects of corporate sustainability reporting, e.g., signaling and legitimacy theory
- Corporate sustainability reporting institutional setting and reporting initiatives, e.g., the Global Reporting Initiative (GRI) standards
- Issues and challenges of corporate sustainability reporting, e.g., greenwashing

Objectifs d'apprentissage

Au terme de la formation l'étudiant-e doit être capable de :

- Identify the basic concepts of corporate sustainability and international standards and guidelines of sustainability reporting
- Develop a critical approach to analyzing corporate sustainability reports and questioning corporate action against the background of their reporting
- Analyse the role of communicating and reporting sustainability-related topics to different shareholder and stakeholder groups of a company
- Express an understanding of the overriding relationships between corporate (financial and sustainability) performance and sustainability reporting
- Define the institutional setting of sustainability reporting and distinguish major reporting initiatives or regulations at the European (e.g., European Sustainability Reporting Standards (ESRS)) and global level (e.g., Global Reporting Initiative (GRI))
