Contenu

After providing a historical overview, the course examines the legal foundations of the structures of organised sports both in Switzerland and internationally. It offers a critical assessment of the operation and governance of the various sport governing bodies as well as the complex legal and functional relationships that exist between them. Particular attention is given to the analysis of the Olympic Movement and of the most important stakeholders in sport, such as FIFA, the World Anti-Doping Agency (WADA) and the Court of Arbitration for Sport (CAS). In addition, the course examines the financing, economics and politics of sport, with a focus on their implications for governance of organised sports.

Forme de l'évaluation

15-minute oral exam with an equal preparation time. Authorised materials: laws, regulations and statutes; no computers or mobile phones.

Please be aware that according to Art. 39(2) REE, students may request to pass their oral exam in French. However, the case study remains in English.

Objectifs d'apprentissage

- Analyse critically the structures of organised sports both in Switzerland and internationally, including that of the various stakeholders which form part of the organised sport system
- Analyse critically the functioning of the structures of organised sports and of these stakeholders from a legal and governance perspective
- Analyse critically the legal relationships between these stakeholders and describe the hierarchical relationships between them
- Analyse critically the performance of each of these stakeholders from a legal and governance perspective, identify and discuss the various challenges they face and the most recent trends in sport
